## INSTALLATION AND OPERATION MANUAL

# FTV/FRV(160,320)(M,S)1(ST,FC)

16- OR 32-CHANNEL 10-BIT DIGITALLY ENCODED VIDEO

The FTV/FRV(160,320)(M,S)1(ST,FC) is a multi-channel ten (10) bit digitally encoded video transmission series. It combines sixteen or thirty-two individual video signals into one high speed digital stream and transmits this over one optical fiber. Both the transmitter and receiver are made up from modules:

- Multiple 8 Channel Video Modules
- One Passive Optical Wavelength Division Multiplexor (WDM)
- One Chassis with integral power supply

The outputs of the Video Modules are combined at the transmitter into a single optical signal by means of the WDM and separated out at the receiver with an identical WDM. While the WDM has provision for five (5) different wavelengths (colors), in this application only two wavelengths are used.

The video channels are referred to in numerical order (1 through 16 or 32). A video input to the channel 3 transmitter BNC connector will be received out of the channel 3 BNC on the corresponding video receiver module.

The transmitters and receivers come completely assembled and tested from the factory. There are no optical or electrical adjustments required or permitted.

Bi-color (Red/Green) LED indicators are provided for rapidly ascertaining equipment operating status. See **Figure 5** on **Page 7** for LED indication explanations.

# IMPORTANT SAFETY INSTRUCTIONS

1. Read these instructions.
2. Keep these instructions.

12. Use only with the cart, stand, tripod, bracket, or table specified by the manufacturer, or sold with the apparatus. When a cart is used, use caution when moving the cart/apparatus combination to avoid injury from tip-over.

Servicing is required when the apparatus has been damaged in any way, such as power-supply cord or plug is damaged, liquid has been spilled or objects have fallen into the apparatus, the apparatus has been exposed to rain or moisture, does not operate normally, or has been dropped.

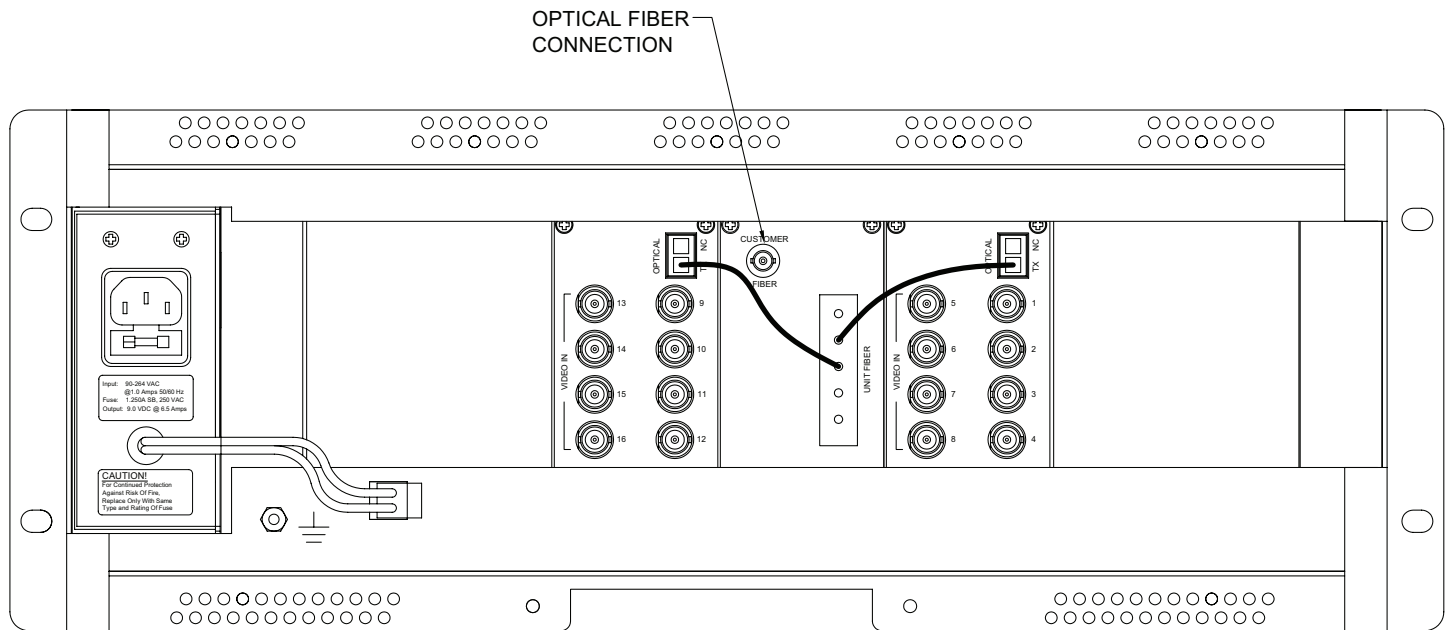

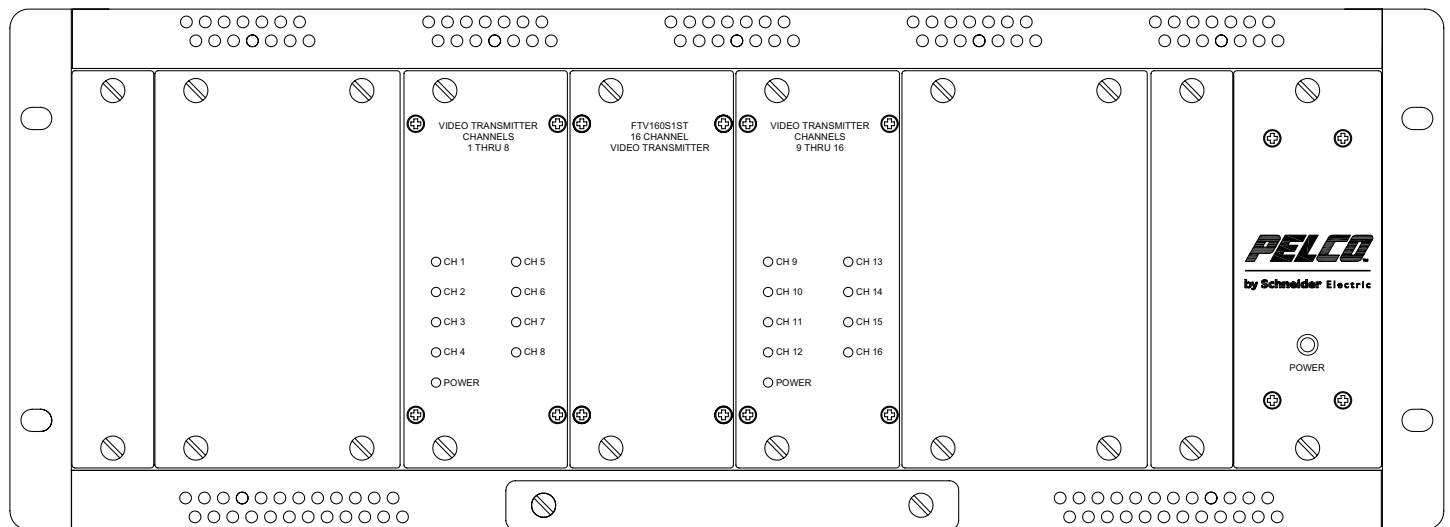
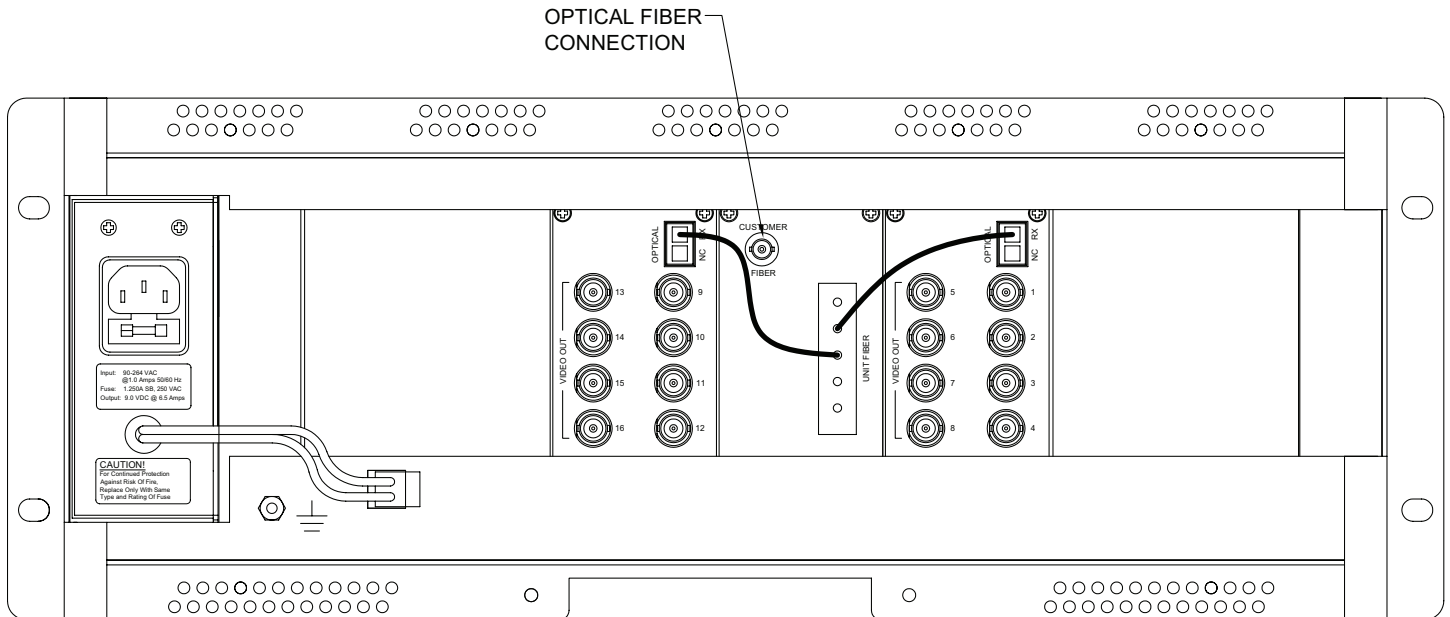


FIGURE 2 – FRV160(M,S)1(ST,FC) FRONT AND REAR

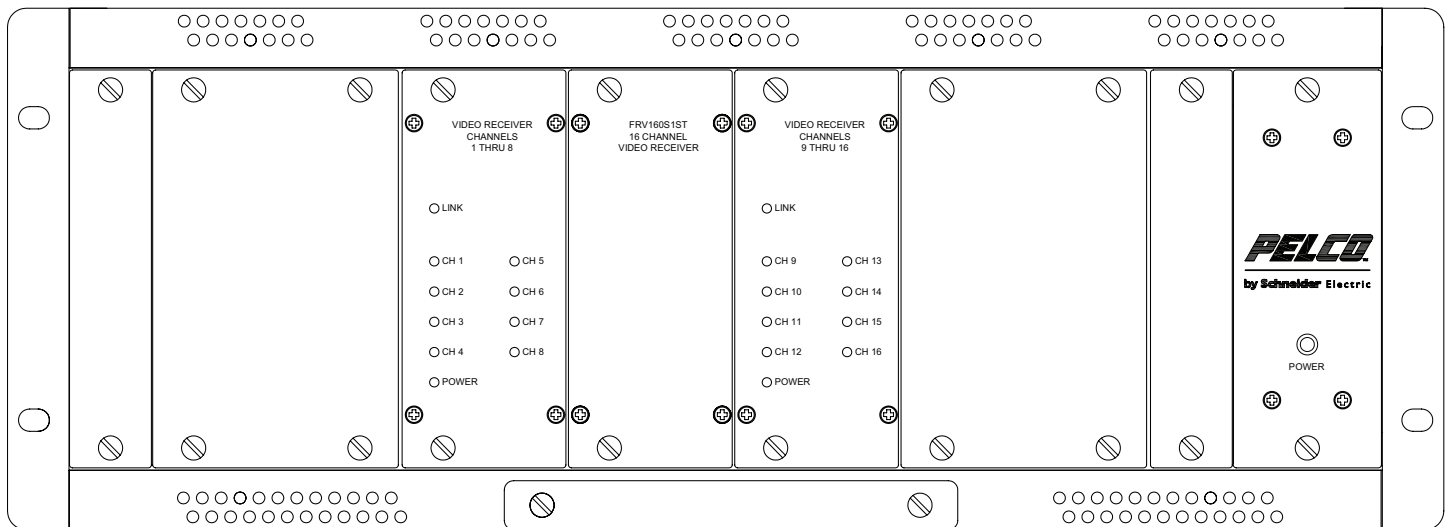
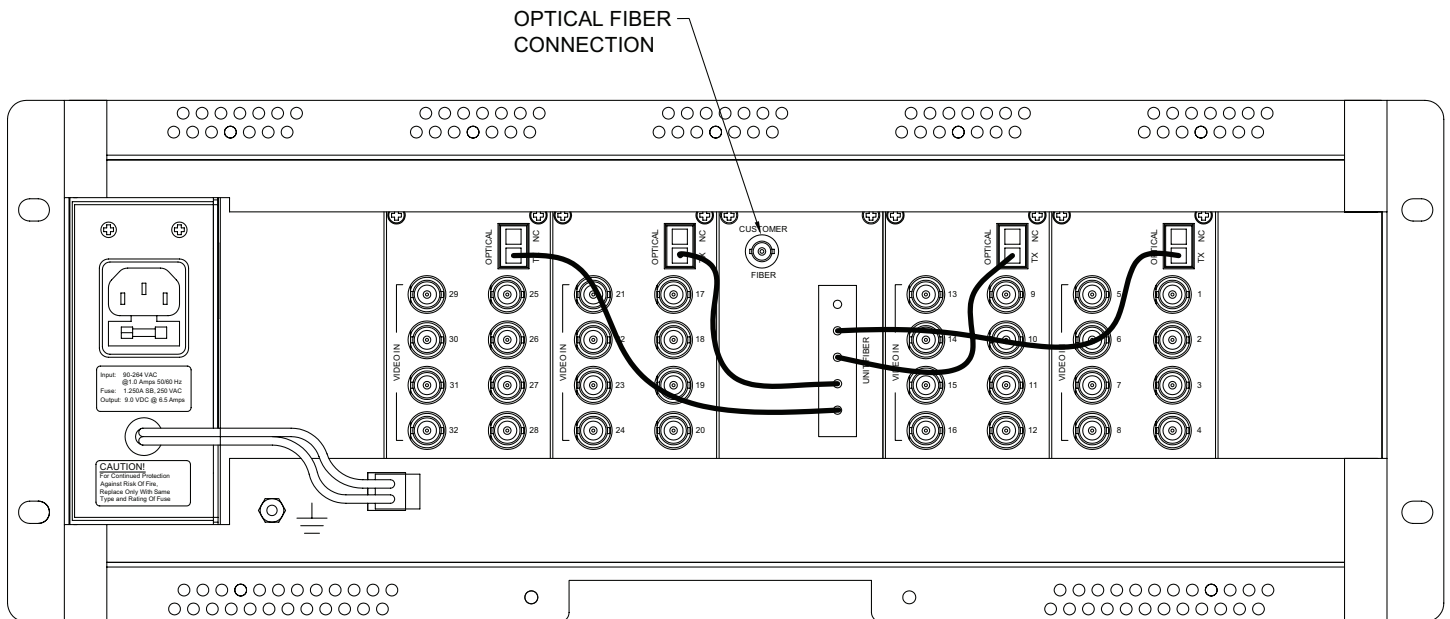


FIGURE 3 – FTV320(M,S)1(ST,FC) FRONT AND REAR

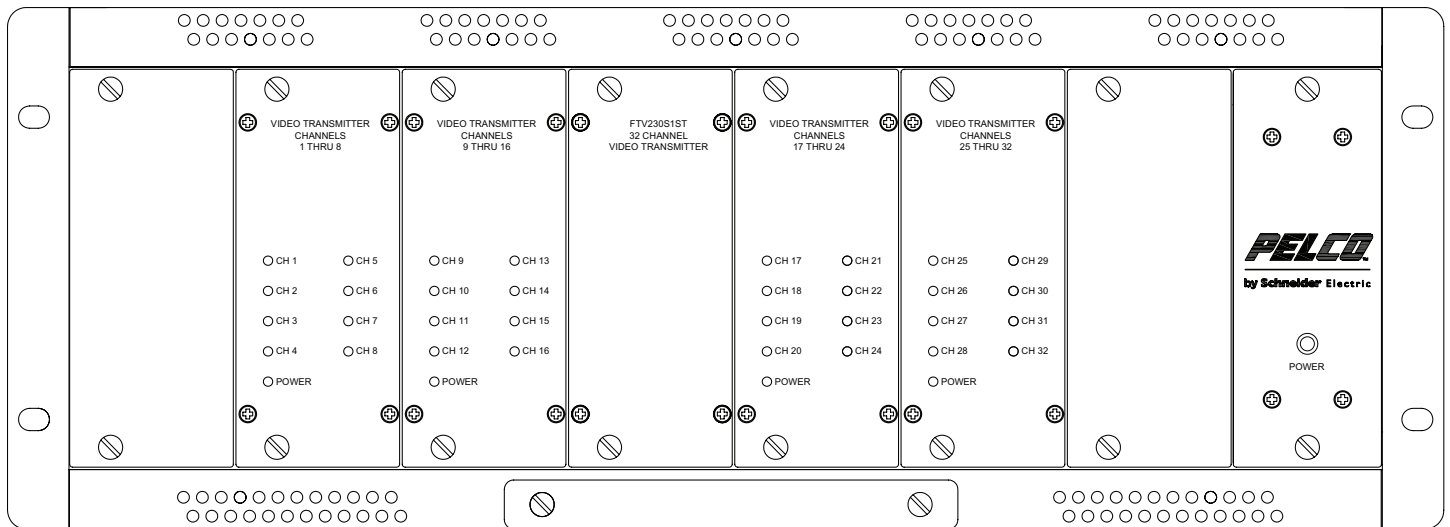
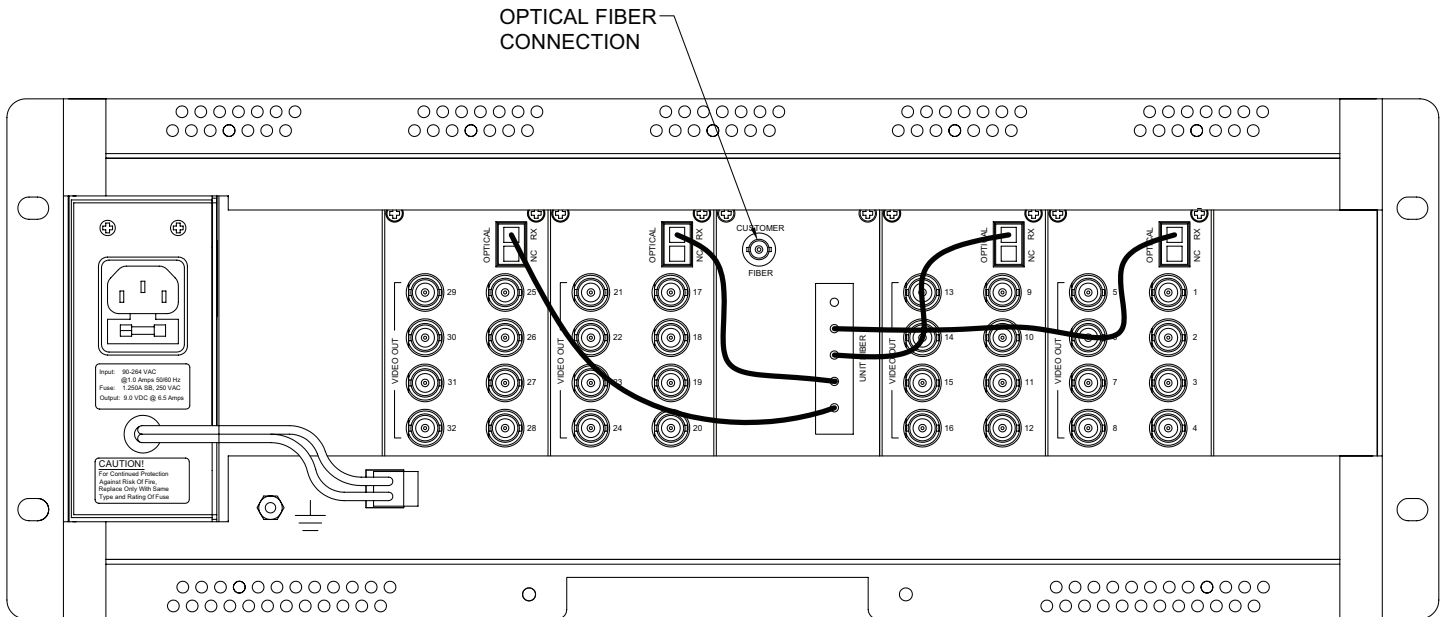
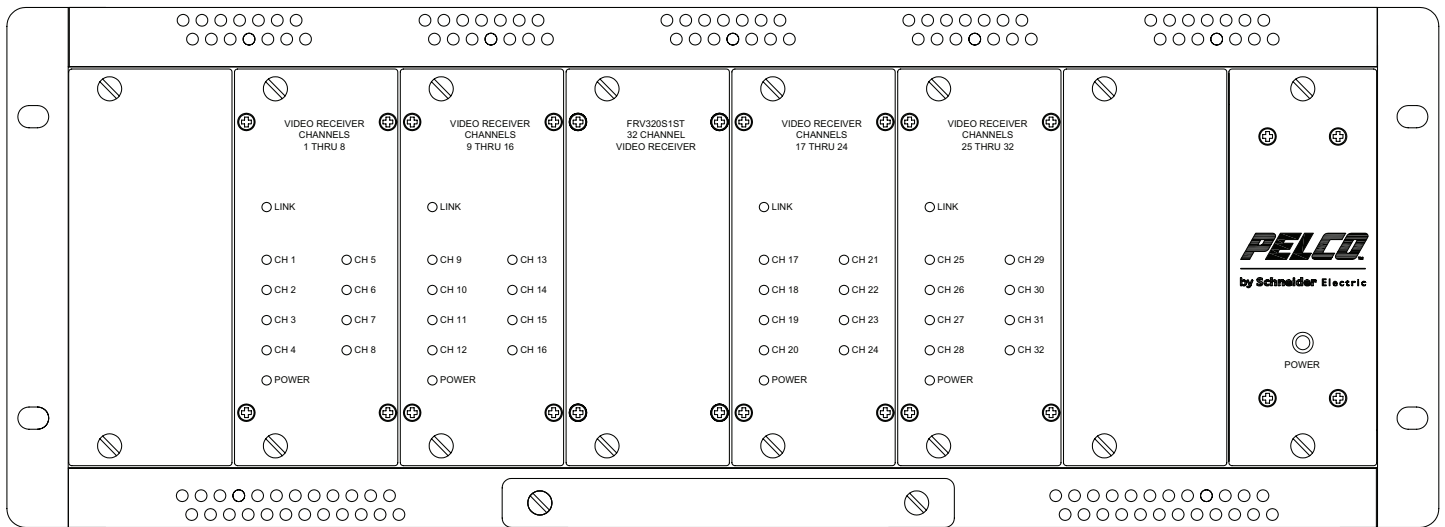


FIGURE 4 – FRV320(M,S)1(ST,FC) FRONT AND REAR

# MECHANICAL INSTALLATION INSTRUCTIONS

## INSTALLATION CONSIDERATIONS

This fiber-optic link is supplied as a Rack. Units should be installed in dry locations protected from extremes of temperature and humidity.

### IMPORTANT SAFEGUARDS:

**A) Elevated Operating Ambient** - If installed in a closed or multi-unit rack assembly, the operating ambient temperature of the rack environment may be greater than room ambient. Therefore, consideration should be given to installing the equipment in an environment compatible with the maximum ambient temperature (T<sub>ma</sub>) specified by the manufacturer.

**B) Reduced Air Flow** - Installation of the equipment in a rack should be such that the amount of air flow required for safe operation of the equipment is not compromised.

## CARD CAGE RACKS

**CAUTION:** Although the units are hot-swappable and may be installed without turning power off to the rack, the manufacturer recommends that the power supply be turned off and that the rack power supply is disconnected from any power source. **Note:** Remove any electrical connector before installing in card cage rack.

1. Make sure that the card is oriented right side up, and slide it into the card guides in the rack until the edge connector at the back of the card seats in the corresponding slot in the rack's connector panel. Seating may require thumb pressure on the top and bottom of the card's front panel.

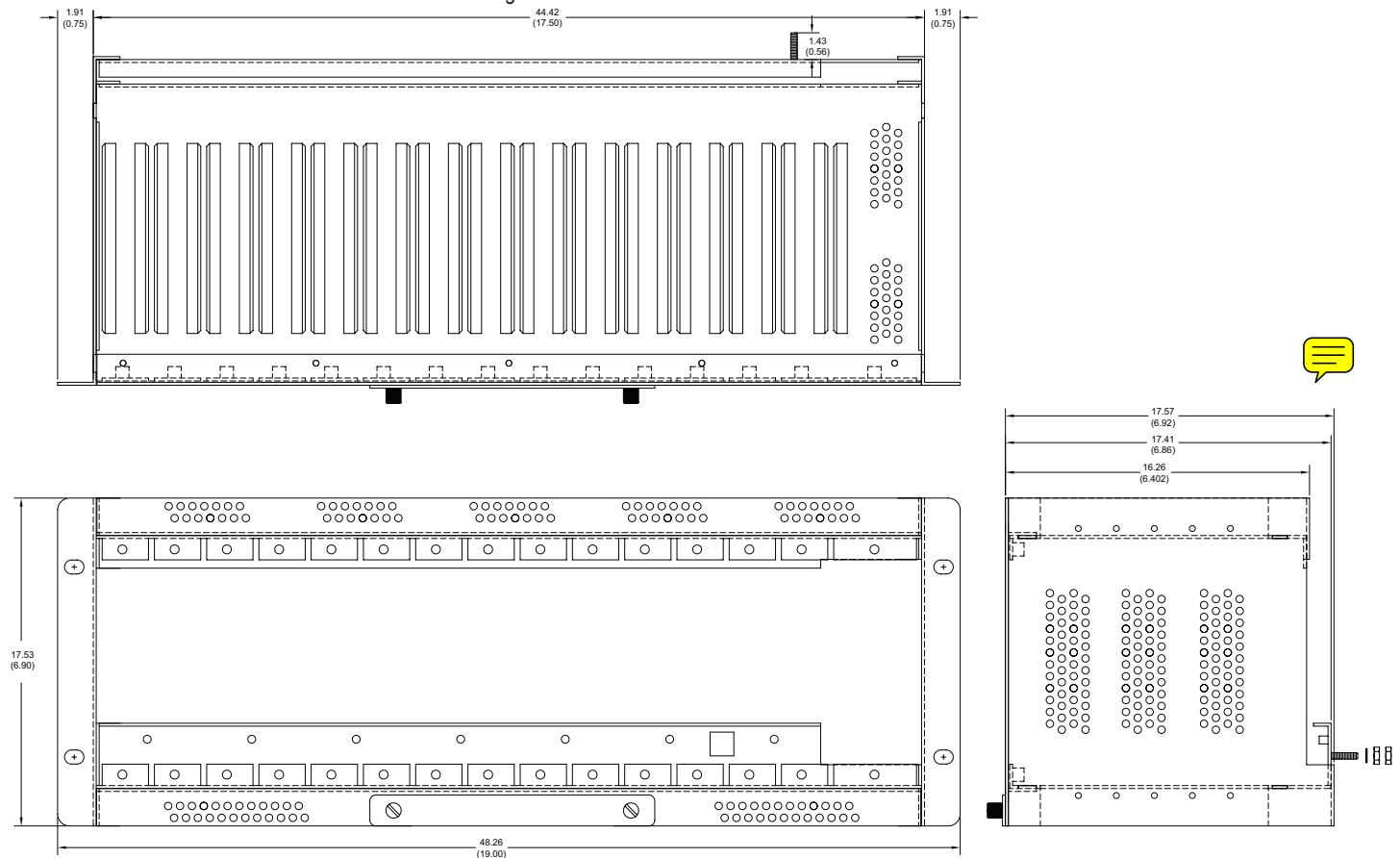
**CAUTION:** Take care not to press on any of the LEDs.

2. Tighten the two thumb screws on the card until the front panel of the card is seated against the front of the rack.

## PRODUCT WARRANTY AND RETURN INFORMATION

### WARRANTY

Pelco will repair or replace, without charge, any merchandise proved defective in material or workmanship **for a period of one year** after the date of shipment.

Exceptions to this warranty are as noted below:

- Five years:

- Two years:
  - Standard varifocal, fixed focal, and motorized zoom lenses

  - Digital Light Processing (DLP®) displays (except lamp and color wheel). The lamp and color wheel will be covered for a period of 90 days. The air filter is not covered under warranty.

- Six months:

- All pan and tilts, scanners, or preset lenses used in continuous motion applications (preset scan, tour, and auto scan modes)

Pelco will warrant all replacement parts and repairs for 90 days from the date of Pelco shipment. All goods requiring warranty repair shall be sent freight prepaid to a Pelco designated location. Repairs made necessary by reason of misuse, alteration, normal wear, or accident are not covered under this warranty.

Pelco assumes no risk and shall be subject to no liability for damages or loss resulting from the specific use or application made of the Products. Pelco's liability for any claim, whether based on breach of contract, negligence, infringement of any rights of any party or product liability, relating to the Products shall not exceed the price paid by the Dealer to Pelco for such Products. In no event will Pelco be liable for any special, incidental, or consequential damages (including loss of use, loss of profit, and claims of third parties) however caused, whether by the negligence of Pelco or otherwise.

The above warranty provides the Dealer with specific legal rights. The Dealer may also have additional rights, which are subject to variation from state to state.

If a warranty repair is required, the Dealer must contact Pelco at (800) 289-9100 or (559) 292-1981 to obtain a Repair Authorization number (RA), and provide the following information:

1. Model and serial number
2. Date of shipment, P.O. number, sales order number, or Pelco invoice number
3. Details of the defect or problem

If there is a dispute regarding the warranty of a product that does not fall under the warranty conditions stated above, please include a written explanation with the product when returned.

Method of return shipment shall be the same or equal to the method by which the item was received by Pelco.

### RETURNS

To expedite parts returned for repair or credit, please call Pelco at (800) 289-9100 or (559) 292-1981 to obtain an authorization number (CA number if returned for credit, and RA number if returned for repair) and designated return location.

All merchandise returned for credit may be subject to a 20 percent restocking and refurbishing charge.

Goods returned for repair or credit should be clearly identified with the assigned CA or RA number and freight should be prepaid.
